- To identify patient needs, agree goals and provide appropriate therapy interventions relating to their physical, functional adaptive equipment and rehabilitation programmes.
- To keep the patient at the centre of care, ensuring patient, parent and carer participation in decision making.
- Engaging in training provided by the company.

## Clinical

- To undertake holistic assessment of children with neurological problems making use of clinical reasoning skills and evidence-based practice in the clinic or community as required.
- To use evidence-based practice, to ensure clinical care is effective and appropriate.
- Design and undertake treatment sessions in the clinic or community as required.
- Organise and manage own time.
- To use standardized clinical outcome measures as part of the assessment and as part of monitoring the impact of treatment.
- Advanced skills in personal communication, ability to motivate yet with an empathic approach
  with patients, family, carers. This will involve using skills where patients may have difficulties
  with communication, cognitive impairment, behavioural problems and pain.
- To work effectively as part of the wider Multi-disciplinary team, coordinating patients care, and making clinically reasoned referrals to other services within this.
- Advise, train and enable parents and carers on therapeutic activities or handling which can be continued outside of physiotherapy sessions, as appropriate.
